

COOKIESTATEMENT

1. The use of cookies

<u>www.maan-specialproducts.com</u></u> uses cookies. A cookie is a small, simple file that is sent with pages from this website and/or Flash applications and stored by your browser on the hard drive of your computer, mobile phone, smartwatch or tablet. The information in the file will be sent back to our servers the next time you visit the site.

The use of cookies is very important for the proper functioning of our website, but cookies that do not have an immediately visible effect are also very important. Thanks to the (anonymous) input of visitors, we can improve the use of the website and make it more user-friendly.

2. Consent to the use of cookies

Your consent may be required for the use of specific cookies. This does not apply to the cookies we use; they do not require your consent.

3. Which cookies do we use and why?

We use the following types of cookies:

- Functional cookies: they ensure proper functioning of our website and a more userfriendly navigation for the visitor. For example: we save your login details or the items you have put in your shopping cart.
- Anonymised analytical cookies: they generate an anonymous cookie each time you visit a website. These cookies know whether you have visited the site before. A cookie is created on the first visit; on subsequent visits the existing cookie is re-used. This cookie is only used for analytical statistics. The data collected by this cookie includes:
 - the number of unique visitors
 - how often users visit the site
 - the pages viewed by the visitors
 - the time of each page view


